## Terms & conditions of Loan

- Equipment is loaned out to current members only and for use by that member alone
- Equipment must be returned to the club in the same condition as it is loaned out, this means you are required to purchase items such as new tires etc in order to so.
- At all times the equipment on loan remains the property of The Junior Hampshire Hornets Wheelchair Basketball Club and must be stored securely.
- Reference to member shall imply members parent or guardian, who shall be deemed the Loaner in respect of the terms and conditions of loan, where the member is considered a minor in the eyes of the law
- All items loaned, need to be covered by your adequate insurance, by signing this agreement you are confirming that you have checked this, and confirm you hold valid insurance to cover the item loaned.
- In the event of damage, unfair wear and tear or loss to the equipment, members shall be liable to a charge equal to the cost of repair or replacement. Currently a Quickie sports wheelchair costs £1500.00. Any repairs required must be undertaken to the satisfaction of the club, at our nominated supplier.
- In the event of the equipment not being returned by the agreed time and in good condition, the hirer will be liable for paying the costs of inconvenience to the club in the retrieval of the equipment.
- Any Equipment on loan is returnable upon demand, or on non-payment of membership fees
- Any member not attending the club for more than three consecutive weeks, will be asked to return the equipment to the club. If the equipment is not returned, the club will arrange collection , the costs of the collection will be charged to the member
- The hirer shall at all times and in all respects indemnify Junior Hampshire Hornets from every expense, liability, loss, claim or proceedings, resulting from damage to property to personal injury arising out of or in connection with or consequent upon the loan, delivery, use or misuse, or collection of any goods or equipment loaned out.
- In the event that the equipment loaned is stolen, you should immediately notify a member of the committee by telephone and email. In addition you should contact the police, obtaining a police reference/report number
- The club has the right to deduct damages, collection costs etc from the deposit held, with any balance payable by the member on demand.

For myself and on behalf of the member named above I accept full responsibility for the listed equipment whilst in our custody or control and agree to be bound by the above terms and conditions. I have satisfied myself that the equipment is in good working order
